K. HEN. VIII. Q. ELIZ.

RICHARD TAVERNER,

Clerk of the Signet in the reigns of Henry VIII. and Edward VI. a Laypreacher, and Author of several religious books,

[Bale, viii. 96.] WAS the son of John Taverner, esq, of Brisley in the county of Norfolk, descended of an ancient family. He was born in the year 1505, and was some time a student [Ath. Oxon. Vol. i. col. 182.] of Bennet-college in Cambridge, but removed to Oxford when cardinal Wolsey founded his new college in that university; of which college he was admitted a junior canon, and took the degree of bachelor of arts in the year 1529. Having acquired a competent knowledge of the Greek language, philosophy, and divinity, he retired to Staire-inn in London, and thence to the Inner Temple. In 1534 he was introduced at the court of Henry VIII. and employed in the service of Thomas Cromwel, secretary of state, who, in 1537, made him one of the clerks of the signet, which he held to the

end of the reign of Edward VI.² But in 1552, being seized with a divine impulse to preach the gospel, he obtained a special licence for that purpoe, and became a celebrated advocate in the Protestant cause.³ During the reign of queen Mary, he lived retired at his seat, called Norbiton-hall, in the county of Surrey. On the accession of Elizabeth, he was particularly noticed by her majesty, in consequence of a congratulatory Latin epistle which he presented on the joyful occasion. She offered him the honour of knighthood, made him a justice of the peace for the county of Oxford, and high sheriff in the year 1569.⁴ He died in 1571. aged 66, in the manor-house at Woodeaton, near Oxford; which mansion he built about the year 1544. He was buried with great solemnity, in the chancel of his parish-church, "by two heralds, who afterwards caused to be hung against the north wall, a helmet, standard, pennon, and other *cognisances* belonging to esquires."⁵

Ant. Wood, having mentioned his being made high sheriff for the county of Oxgord, says - "in which office he appeared in St. Mary's pulpit, with a sword by his swide, (as 'tis said) and a chain of gold hanging about his neck, and preached to the scholars a sermon (there being then a great scarcity of divines in the university) beginning thus - Arriving at the mount of St. Mary, in the stony stage where I now stand, I have brought you some fine Biskets baked in the Oven of Charity, carefully conserved for the Chickens of the Church, the Sparrows of the Spirit, and the sweet Swallows of Salvation, &c.

⁵ Esquires. They are the words of Ant. Wood. But these *cognisances*, as he calls them, I should have considered as belonging to *knights*, rather than *esquires*; and hence I am iinclined to believe that Taverner really accepted the honour of knighthood from queen Elizabeth.

Taverner, Richard, b. at Brisley, Norfolk, 1505; studied at Cambridge, Oxford, and the Inner Temple; became a Clerk of the Signet in 1537; received (though a layman) a special license to preach the doctrines of the Reformation, 1552; was made High Sheriff of Oxford, 1569; d. 1575. He was a learned man, and published a number of translations, &c., of which we notice:

Thanks him for his goodness when he was last with his Grace. Sent for Taverner, a singing man, to be informator of the children of Wolsey's chapel in his college at Oxford, but cannot induce him to give up his living at Tatessall, and the prospect of a good marriage, which he would lose by removal. Advises Wolsey to appoint some man of his chapel. And it shall be meet for him that your Grace will appoint thereunto to have both his breste att will, the handling of an instrument, pleasure, cunning and exercise in teaching, and to be there four or five days before your appointed day, for the ordering of his children, to feel them, to know them, and to be acquainted with such songs as shall be the day of solemnity there sung. There is no doubt Wolsey will have a good choir. Reminds him to procure rectors' staves, and cross staves, and a good pair of organs; less than two pair will not do.

Was present at the marriage of Henry VII. at Westminster, and at the creation of Arthur prince of Wales and Henry duke of York. They were always considered as brothers, and he never heard it contradicted. Was present at the marriage of prince Arthur with Katharine, now Queen, at St. Paul's, in Nov. 17 Hen.VII. 1521 (sic). Believes that Arthur was then 14 or more. Saw the queen Elizabeth and him a month after his birth, at Winchester, in

Supposes that the Prince consummated the marriage,—as he did so, being only $15\frac{1}{2}$ years when he was married. They were always considered lawfully married during the life of prince Arthur. And when the King understood that it was his confessor, he commanded to let him in; which confessor, after due salutation, began to say, 'Si bona de manu Dei suscipimus, mala autem quare non sustineamus?'—and so showed his Grace that his dearest son was departed to God."

In another ancient book of calendars (calendarum) — "This day was born the lord Herre, 1481" (sic), on 28 June; and in another—"Nativitas R. H. VIII., 28° die Junii 1491, Greenwich." Marriage of prince Arthur and Katharine at St. Paul's, 24 Nov. 1501.

In the Council Chamber they found a printed book of the names of the bailiffs, mayors, and sheriffs of the city of London, with this passage:—"This year (17 Hen. And the Tuesday after, all the court removed to Westminster by water, and the marriage,* with all the crafts with them, in barge[s], with trumpets, shawms, and tabrets, in their best manner. And ther the King held royal jousts, tourneys, and banquets six days after, and then removed to Richmond, &c."





In 1535 the English reformer Miles Coverdale published an English translation based on German and Latin versions in addition to Tyndale's. This was not only the first complete English Bible to appear in printed form, but unlike its predecessors, it was an approved translation that had been requested by the Canterbury Convocation. Shortly thereafter, the English reformer and editor John Rogers produced a slightly revised edition of Tyndale's Bible. This appeared in 1537 and was called Matthew's Bible.

In 1538 the English scholar Richard Taverner issued another revision. At about the same time, Thomas Cromwell commissioned Coverdale to produce a new Bible, which appeared in six editions between 1539 and 1568. This Bible, called the Great Bible, in its final revision in 1568 by scholars and bishops of the Anglican church was known as the Bishops' Bible. The Bishops' Bible was designed to replace not only the Great Bible, which was primarily a pulpit Bible, but also a translation for the laity, produced in Geneva in 1560 by English Protestants in exile, called the Geneva Bible. The Bishops' Bible was the second authorized Bible.

The first great flowering of what would now be identified as chamber music came in England in the late 16th and early 17th century, where a large amount of music was written for groups of between four and seven viols—the so-called viol consort. The music was of an intimate, often emotionally intense nature. One of the typical forms in which viol music was written was the *In nomine*, a fantasia based on an old plainsong melody that had become famous when it was set to the words "In nomine Domini" in a mass by the early 16th-century composer **John Taverner**. Christopher Tye wrote 20 *In nomine* settings that showed the steady development of a distinctive instrumental style, using to the full the viol's six strings and capability for wide leaps. William Byrd wrote seven distinguished settings, and the form continued well into the 1600s, with Henry Purcell producing two magisterial settings, in six and seven parts, around 1680.

Fantasia, instrumental musical composition in a free form, that is, any composition in which the composer lets imagination, or "fantasy", prevail over the rules of a set musical form. The word is first used right at the beginning of instrumental music composition in the mid-16th century, to describe a piece that was not a transcription of a vocal work. In the late 16th and early 17th century it was a title used for many brief keyboard and chamber music works, beginning in Italy and spreading to other countries from there. In England it became associated with music for the viol consort, with composers such as Byrd, Gibbons, and Purcell writing many notable examples. In later Baroque and Classical music the term was often applied to improvisatory opening sections of works, such as the Fantasia in G and Fantasia and Fugue in G Minor, for organ, and Chromatic Fantasia, for harpsichord by J. S. Bach. Other examples of the fantasia are Fantasia in D Minor by Wolfgang Amadeus Mozart and Fantasy in C Major by Robert Schumann, both for piano.

During the 19th century the term gradually waned in use, as the range of musical forms increased to meet the programmatic demands of Romanticism. Nonetheless some significant works titled Fantasy have been composed since then, including the Fantasia and Fugue on Meyerbeer's *Le Prophète* by Franz Liszt, Fantasia on a theme of Thomas Tallis by Vaughan Williams and two works by Peter Maxwell Davies called Fantasia on an In Nomine by John Taverner, recalling the subject of the great viol fantasias of the English Renaissance.

Taverner, John (c. 1490-1545), leading English composer of the early Tudor period. He possibly grew up in Lincolnshire, singing at the well-endowed collegiate church of Tattershall, then worked in London (1514-1520), but neither assertion has been proven. Indisputably, he was singing in 1525 as a clerk-fellow at Tattershall and the following year was appointed choirmaster at the newly founded Cardinal College, Oxford (now Christ Church), where he was implicated in a Lutheran heresy incident, then pardoned by Cardinal Wolsey. The College declined when Wolsey fell out of favour with Henry VIII, and Taverner left in 1530, later retiring to Boston, Lincolnshire, where he spent his last decade as a respected civic dignitary. Though acting on behalf of Thomas Cromwell in acts of Reformation destruction and dissolution in Boston, it is now thought likely he remained a Catholic. Taverner's music is the epitome of the florid English style linking the Gothic to the high Renaissance. Influenced by the Eton Choirbook composers such as Cornyshe and Fayrfax, his works show a greater control of structure and tonality, and favour imitative techniques. His later works are simpler, pointing the way for Sheppard, Tye, and Tallis. His output includes eight masses, three of which are elaborate festal settings in six parts, for example, the Missa Gloria tibi trinitas, three Magnificats, votive antiphons, and responds including *Dum transisset* Sabbatum.

Has received to the king's use the four houses of friars in Boston, very poor houses and very poor persons, and delivered them to Mr Taverner and Mr Johnys, the king's servants, with all the poor implements for his money. Received also on the way a house of Austin Friars in Huntingdon and delivered it to Philip Clampe according to the Chancellor of the Augmentations' letter. These houses are all meetly leaded. After our right harty commendacions. Thise shalbe to require you to significe unto the Kinges Majeste, that meting yesterdaye togither here, at the house of me, the Lord Chancelour, for thexamynation of the Duches of Norffolke, to thintent we might be the better armed for that purpose, we thought it expedient first to begyn with Ashby, her man, and to see what he had confessed; who being in the custody of me, the Chancelour of thAugmentation², had writen, by commandment, on Sonday night, thre or four leaves of paper; in the perusing wherof, we founde, amonges many long tales of small

importance, that when the Duchess had broken up Derams coffres, wherat the said Ashby, and her comptroller, a prest, were present, besides the smythe who piked thone coffer, and brake open thother, she toke out all the writinges, and caried them in to her chamber, saying she wold peruse them herself at leysour, without suffering any body to see them with her; the like wherof she did, also, with suche writinges as were in his male; and to declare that she ment not to have any of those thinges cumme to revelation, she wold have had Ashby to have taken a cote of saten of Derams for thirty shillings and eight pence, whiche Deram ought him, but he refused it: he confessed, also, that the Duches hathe been in greate feare, lest Alys Wylkes told the Lord William of the famyliaritie betwene the Quene and Deram, and that she wold have sent oon to Calays, to have enformed the Lord William of this matier, if she had not been advised to the contrary: he confessed, also, her serche for the perdon, and that she ones said, if there be non offence doon sithens the mariage, she ought not to dye for that whiche was doon befor; and also that she demaunded, whither the pardon wold not serve other, that knewe of their naughty lief, befor the mariage: and also he confessed, that she brake up a chest and two coffers of Damportes, after he was commytted to the Tower, and likewise toke out his letters and writinges, being present, at this breaking also, Ashby, her comptroller, and oon Dunn, yoman of her celler, who plaid the smythes parte. When we had perused thise thinges, and comoned with the said Ashby uppon them, we thought mete to sende for the comptroller, for oon Boroughe, her chaplain, of whom she had the boke of statutes, and for her clerc of the kychen, who had been at Hamptoncourte, and were all touched in Ashbyes confession. Dunne we sent not then for, bicause it was afternone, er we knewe, by Ashby, or any other, of the breaking of Damportes coffres; whiche personnes were with us immediatly after dyner; of whom we gat no more, in effecte, then Ashby confesseth. And in the meane space, betwen this first examynation of Ashbyes doinges, and dyner tyme, we examyned again Jane Ratsey, whose deposition you shal receyve herwith, to be shewed to His Majeste.

We examyned, also, partily befor dyner and partily after, a newe matier, that the Lady Anne of Cleves shuld be delyvered of a fayr boye, and whose shuld it be but the Kinges Majestes, and gotten when she was at Hamptoncourte; whiche is a most abomynable slander, and for this tyme, and the case in ure, as we thinke, most necessary to be met with all. This matier was told to <u>Taverner</u>, of the <u>Signet</u>, more then a fortnight a goo, bothe by his mother in lawe, Lambertes wief, the goldsmythe, and by vol. 1.

RICHARD TAVERNER

Taverners oune wief, who saithe she hard it of Lilgraves wief, and Lambertes wief hard it, also, of thold Lady Carewe; Taverner kept it; and they, with others, have made it a commen matier of talk, and never reveled it tyl Sonday night; at whiche tyme he told it Doctour Cox, to be further declared, if he thought good; who immediatly disclosed it to me, the Lord Privy Seale. We have commytted Taverner to the custody of me, the Bishop of Winchester, and Lambertes wief, who seamethe to have been a

dunse in it, to M' the Chauncelour of thAugmentacions.

With this, also, cam knowleage to us, that Damport desired to speake with oon of the Counsail, and soo went to him I, Sir John Gage, and I, Sir Richard Riche; and his sayeng, for that tyme, was, that Deram said ones to him, when the Kinges Majeste favored Mistres Katherin, " I could be " sure to Mistres Katherin, and I wold; but I dare not. The King begyn-" ethe to love her; but, and he were deade, I am sure I might mary her." And bicause Damport confessethe this nowe, and wold not do it for any torture he could befor be put to, we have resolved that bothe he, and Deram, shalbe seriously exampned again, this daye, of certain pointes, whiche we have noted for that purpose. And havinge passed the greate parte of thaftrenone in thexamynations of the persons and matiers befor specefied, arryved the letters, with those sent to the Kinges Majeste out of Fraunce, soo that, befor we had perused them, it was derk night, and therfor we have determined, this daye, tintende holly to the Duches examynation, with suche other as be befor mentioned; and, as we shal procede, tadvertise: having thought convenient to write thus moche, to thintent the Kinges Majeste may have a just accompt and knowleage of our doinges.

And you may also shewe His Majeste, that I, the Lord Privy, shal doo what I can to thaccomplishment of His Majestes pleasure concernyng

M' Southwell, trusting to frame it according to His Majestes desire.

We be also enformed that Deram maketh humble sute for the remission of summe parte of thextremytie of his jugement, wherin we require you to knowe His Majestes pleasure. Where by the former depositions it seamed, the comptroller was at the breaking both of Derams and Damportes coffres, it appered after that, he was only at the breaking of Damportes coffers, which breaking of Damportes coffres the Duches confesseth not, ne hathe yet touched in any conference with any person. Damport confesseth, also, that Deram told him, the Duches of Norffolke said to a gentlewoman in the Quenes chambre, when Deram was present, pointing to him, "This is he "that came in to Irlande for the Quenes sake." You You may also shewe His Majeste, that I, the Lord Privy Seale, trust to fynde out summe pythie matier of Alys Wylkes. As I shal fynde, I shal advertise.

Thexamynation of Jane Ratsey was sent to you yesternight.

CLXVII. THE COUNCIL WITH THE KING to THE COUNCIL IN LONDON.2

It may lyke Your good Lordeshippes tunderstonde, that the Kinges Majeste hath perused, and maturely digested your letters, sent yesterday dyrected to us, Sir Anthony Browne and Rafe Sadleyr; and doth pryncypally note these poyntes hereafter specefied, which, as appereth by your saide letters, are confessed by Assheby.

First, that the Duches, after the breking open of Derams coffres, toke out all the wrytinges, and caryed them into her chamber, saying she wolde peruse them her self, without suffering any body to see them with her; and also that she did the like with all the wrytinges in his male; which declareth not onelie that she was very diligent to gather togither all his wrytinges, but also, as His Majeste thynketh, that the same her doing can not be construed to any good entent: wherefore His Majeste thinketh it good, that she be examyned, uppon what grounde she opened the said coffres; and if she shall answer that she opened them, to thintent to sende the wrytinges unto

On this day (Dec. 6.) the Council gave an order for locking up all things at the Duchess of Norfolk's house at Horsham, which order was, on the 9th, extended to other houses of the Duchess, of Lord William Howard, and of Lady Bridgewater. The latter order appears to have been issued in pursuance of the King's commands.

CLXX. THE COUNCIL IN LONDON to THE COUNCIL WITH THE KING.

After our right hartie commendations. Itt shall like you tunderstand, that yesternight, late, we receyvid your letters, written the same daye att Oteland; and by the same doo perceyve the Kinges Majestes good acceptation off our service, whiche is to owr singuler comfortes; and allso His Graces resolution and pleser towching the parsons, whereoff we wrote unto yow in owr last letters, whiche wee shall endevour owrselffes to follow, as apperteyneth. Nevertheles, forasmoche as in your former letters, you signified that His Highnes wolde have the Duches off Northffolke eftsones examined uppon certeyne poyntes, in the same lettres conteyned; whereupon we have allredie conceyvid certayne interrogatories, the copye whereoff wee send unto yow herewith, with the dobles allso of thothers, whiche His Majeste perused and amendid att Assher, wee have thought mete to bestow this day in the calling, examination, and committyng of the Lorde William, and in thexamination of the Duches, where her money and treasure is bestowed, to thintent we may certaynely know His Majestes pleser, befor owr further procedinges, towching the poyntes following:

Fyrst, whether we shall wade any further in examination with the Duches upon the sayde interrogatories, or leave her thus to be convinced by testimonye.

Seconde, forasmoche as she is olde and testye, and may percase, upon the committing of her, take itt so to hart, as might putt her in perill of her life, whether His Majeste woll that she, and all the rest specified in owr sayde former letters, shall be indicted of misprision of treason, whiche we thinke may be don within four or five days, wherebie the Parliament shall have better grownde to confiscke theyre gooddes, if any of them shold chawnce, before theyre atteyndour, to die. And where His Majeste hath most gratiouslie consideryd Mary Lasselles refusall of the Quenis service, and the first opening of the matier, to be a good grownde, whereupon His Highnes may extende mercie to her, willing us to signifie owr opinions in the same; we require yow, on owr behalffes, to declare to His Majeste, that we thinke His Highnes hath therein most gratiowsly determined: desiring, nevertheles, to know, whether she shall be indicted; or left owt, if the saide indictment shall procede, as we thinke itt mete, if itt shall so stande with His Majestes pleser; for whiche pourpos we have caused my Lorde Chief VOL. I. 4 X Justice

Justice to tarrye still here, who, with M' Attourney, M' Pollard, and M' Sollicitor 1, have been daylie attendant and busied with us, sithens the first examinations off thiese mattiers.

Thirde, forasmoche as itt apperith by the relation of Mr Lieutenant, there be nott romes sufficient in the Towar, to bestow them all severallye, onles they shall be lodgid in His Majestes and the Quenes lodginges, we beseche His Majeste, in cace he be pleased herewith, to sende hither his doble key, or to give us leave to altre the lockes, for this tyme, or ells to signific unto us, whether His Majeste woll have the great personages committed thither, with suche others as may conveniently be plased, and the residue to remayne in other custodies, till mo romes may be prepared for them.

Fowrth, what ordre His Majeste woll have taken with theyre servantes, whether suche, as have no freendes or dwelling places, shal, for a tyme, be kept togyther, and the rest dispeched with any rewarde, or the hole discharged att ons, with rewarde, or otherwise, as to His Majeste shall be thought most convenyent.

Fift, we require yow to shew His Majeste, that all yesterday we traveilled with the Ladie Bridgewater, Bulmer, and Wilckes; and as for Bridgewater, she sheweth herselff her mothers dowghter²; that is, oon that will by no meanys confesse any thing that may towche her: and allso, that where we wrote that Doctour Peter shold go to Horsham, he being owt of the Towne, we sent thither, in his stede, His Majestes Sollicitour, who putt allthinges there in ordre, and appoynted Mr Carrell, dwelling bye, to have an eye daylie to the same.

We have, allso, sent for thofficers of the Ladie Anne of Cleves, and for Dorothe Wingfelde, Jhon Wingfeldes wife, whiche is of her pryvie chamber; and have committed Tavernour, and Lylgraves widdow, who apperith yett the first authour off the bruit, to the Tower. And we have allso traveiled, to the best off owr powers, with Jane Ratsey; and more than she hath allredie confessed, we can nott gett of her, albeit we had ons committed her to the Lieutenaunt, as though she sholde have bin committed to the Towar, and finally eleft her in the custodie of me, the Lorde Chawncellour. The woman semith most sorrowfull, as to have ben movyd uppon none other occasion then is before written. Desiring yow, allso, to know His Majestes pleser,

Yesternight received their letters written the same day at Otelande. Upon their former letters, have conceived interrogatories for the Duchess of Norfolk, which are sent herewith, with the copy of those the king amended at Assher. Have thought meet to bestow this day in calling, examining, and committing lord William, and examining the duchess as to where her money and treasure is, before proceeding further. As she is old and testy, and might take her committal to heart so as to endanger her life, ask whether to indict her and the others, which may be done in four or five days, whereby Parliament shall have better ground to confiscate their goods if any of them should chance to die before their attainder. Think that in the case of Mary Lasselles the king has most graciously determined, and ask whether she shall be put in the indictment. Detain the Lord Chief Justice, Mr Attorney, Mr Pollard and Mr Solicitor, till they know the king's pleasure. Mr Lieutenant says there are not rooms to lodge them all severally in the Tower, unless the king's and queen's lodgings be taken. Beg that the king will send hither his double key or permit them to alter the locks, or else signify whether the great personages may be committed to the Tower and the rest to other custodies until rooms may be prepared for them. Ask whether the servants who have no friends shall be kept together and the rest despatched with rewards, or the whole discharged. All yesterday they travailed with Lady Bridgewater, Bulmer and Wylckes. Bridgewater shows herself her mother's daughter, and will confess nothing.

RICHARD T. of N. ELM HAM.

Dr Peter was out of town and the king's solicitor went to Horsham in his place.

Have sent for the officers of lady Anne of Cleves and for Dorothy, John Wingfield's wife, of her privy chamber, and committed Tavernour and Lylgrave's widow, who appears the first author of the bruit, to the Tower. Can get nothing more of Jane Ratsey, who remains in custody of the Lord Chancellor.

Desire them to inform the king that, meeting yesterday at the Lord Chancellor's to examine the Duchess of Norfolk, they thought best to begin with Ashby, her man, being in custody of the Chancellor of Augmentations, who had written on Sunday night [4 December 1541] three or four leaves of paper. Give the important points in his confession, showing that the duchess broke up Deram's coffers and took away all writings in them; that she had been afraid Alice Wilkes would tell lord William of the familiarity between the queen and Deram, and intended to send to Calais to inform lord William; that she searched for the pardon, and said the queen ought not to die for offences before marriage; that she broke open Damport's coffer after his committal to the Tower, and took out his papers. Her comptroller, one Boroughe, her chaplain, of whom she had the book of statutes, the clerk of her kitchen, and one Dunne, yeoman of her cellar, being named as accessories, examined the first three, but could learn nothing new. Also re-examined Jane Ratsey and examined a new matter, viz., "that the lady Anne of Cleves should be delivered of a fair boy, and whose should it be but the king's Majesty's, and gotten when she was at Hampton Court?" This abominable slander was told to Taverner, of the Signet, by his mother-in-law, wife of Lambert, the goldsmith, and by his own wife, who said they had it of Lilgrave's wife and the old lady Carowe. Taverner kept it secret till Sunday, when he told Dr Cox, who informed the Lord Privy Seal. Taverner is in custody of the Bishop of Winchester and Lambert's wife in that of the Chancellor of Augmentations.

Word then came that Damport desired to speak with one of the Council, and sir John Gage and sir Richard Riche went to him, when he said Deram once told him, "I could be sure to Mrs Katharine an I would, but I dare not, the king beginneth to love her, but an he were dead I am sure I might marry her." The Lord Privy Seal expects to learn some pithy matter of Alice Wilkes. Jane Ratsey's examination was sent yesternight.
