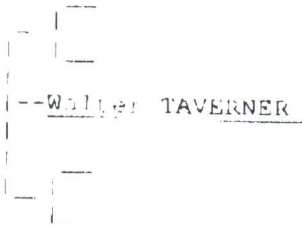

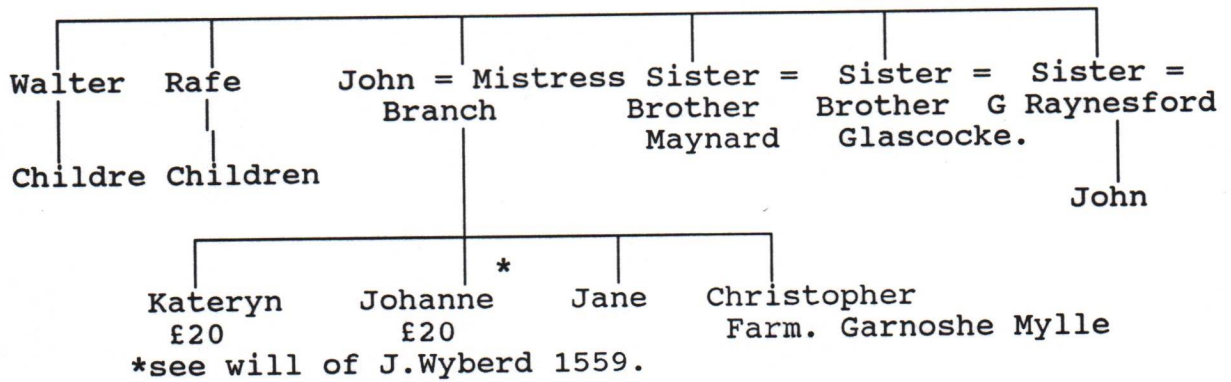

A lettre to Sir Roger Cholmeley and Doctour Marten to repaie to the convicte prison at Westminster, and to proceade to the further examinacion of **Silvester Taverner**, prisoner there, who, having imbeaselyd certaine plate and other goodes, aswell bilonging to the Quenes Majestie as to sundry other personnes besides, will by no meanes hitherto declare where the same is become, notwithstanding the matter is alredy confessed against him by two others; and therefore they are required, for the better atteyning of the trueth, to put him to suche tortours as by thier discreacions shalbe thought convenient, for whiche purpose the Keper of the said prison is likewise written unto in that matter.

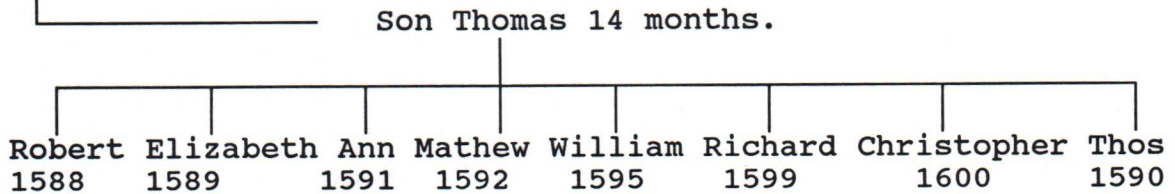

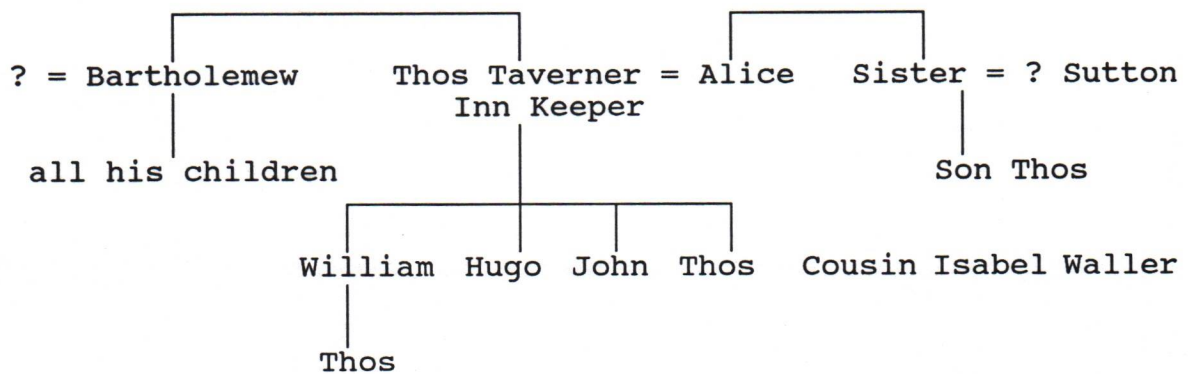

Thomas Taverner of Billingborough - wills in Lincoln.

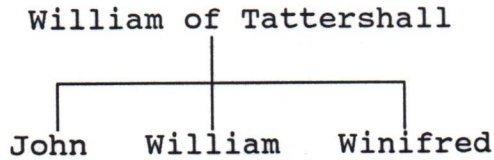

So we shall say that the Lady Mary of Pakenham fellow is the fourth, who officiates on his own with prayers for her and for the lord of Hemenhall. We shall say that for the sustenance and clothing of this fellow, the clothing of the master and his colleagues, and the 'distributions' as they call them, was given to the college the advowson of the church of Great Matsalle, of a yearly rent at that period of 40 marks silver, in our time only £12. Of which, if you reckon the 20s a year to be paid to the Bishop of Norwich for tithes, the cost of a pound of incense due each year to the Bishop of Ely, and 8 marks silver for the fellow's salary, and 13s 4d for clothing or, as they call it, livery, of the same: and moreover, if you reckon 20s for the master's clothing and that of the other seven colleagues 7 silver marks, that is 13s 4d each, but excepting Dr Bayly's fellow: finally, if you include the small distributions (as they call

FONS

them) of the master and each of the nine fellows, to wit 12d at the feasts of Easter and Christmas, a total of 20s, in all £13 13s 4d and more, the whole yearly rent of the benefice of Matsall is consumed, and the college will be burdened with 4 marks and more yearly costs: and there is nothing left over to feed the other and further fellow. Nor is there any reason why the college should at its own expense feed that person serving Lady Mary: on the contrary, it would be fairer to exonerate the college (which ought not to be burdened with any outside expenses) from the 4 marks silver granted to the four last fellows of the college before Dr Bayly's fellow for livery, and the 8s for distributions paid to the same at the college's expense should be withdrawn, by which reason they are withdrawn from Dr Bayly's fellow, to wit, because those liveries and distributions were granted then when there were only four fellows, nor was it certainly known that there would be more in the future. But because in the third foundation there is mention of ten fellows, and in the books of visitation also ten, and in the one place is entered William Barker, in the other Andrew Person, as the fellow of Lady Mary of Pakenham, by when neither was the former a fellow (if in our times) nor the other ever was, it hardly arose from knowledge of the condition of the college. For when it was realised that there was nothing with which to feed another fellow for the college, and they decided that another should not be fed, they wanted to discover those resources which they suspected the college to have been founded with. But Thomas Wendye and Edward Crome, doctors of medicine and theology respectively, grave and trustworthy men, and fellows of our college once before our time, and both still living in 1560, used to say that in their times they never saw ten fellows, nor in our time [1563] have we ever seen ten, even we, Richard Taverner, Andrew Deane, William Barker and William Botswayn, who alone of all the fellows of our time are now still living. And let me also dare to affirm that, before the third foundation, there were not more provided for than were provided for in our time. But in our time was the last man who was a Dr Bayly's fellow, and that last man stayed until the third foundation. Only Dr Wendie knew there to be eight. Dr Crome was the first to know nine, the executor of the will of John Bayly, whose fellow we have said to have been the ninth. But because in the last letters of foundation, there is mention of ten fellows in a previous period, we have spoken of the tenth fellow of the college, and while I was master we have established him to eat at its expense, as we shall set out in the second book.

TAVERNER'S CASE.

Forging the customary of a manor which tends to the disherison of the lord, and affixing seals to it, is within 5 Eliz. c. 14.

And, in a suit for that in the star chamber, the crown may pardon the corporal punishment without the party releasing.

The execution for the double costs and damages is by English writ, directed to the sheriff, of the goods, chattels, and profits of the lands of the offender,

James Taverner, being a copyholder to the Lord Crumwell of his manor of Northeltham in the county of Nor. made a customary in Latin of the said manor on parchment, with eleven labels and seals of his own and other tenants of the manor, inserting therein divers customs, very false, tending openly to the disherison of the lord, and pretending by the title of the said customary, to be collected, renewed, and set forth by the consent of all the freeholders and copyholders of the manor, being in number 100 at least, and allowed and permitted by the lord of the manor: and in the conclusion, "*in witness whereof the eleven* (whose names were subscribed), *have put their seals the dat and*

year above said." But no day or year appeared in the title, and no consent of all the tenants, or allowance of the lord in fact had. And the seals were very strange, for to each seal there was a large square seal engraven about Northeltham, and the particular seal less within that; by which as it seems the intent was to prove the affirmance of the lord † *with* the consent of all the tenants &c. And this was proved in Taverner to be done wittingly, subtilly, and falseley, and to the intent &c. Whether this be a forgery punishable by the statute of the fifth year of the present queen [c. 14.] (this act being committed in the ninth year of the present queen [17 November 1566 - 16 November 1567]) was doubted, and referred by the lords to the considerations of all the Judges; whose opinions for the major part were reported by the two Chief Justices, that it was a forgery, or falsifying, punishable by the open and shameful penance contained in the statute; which expressly speaks of a *writing sealedu*, as this was, and *to the intent to benefit themselves*, and *to disinherit the lord*. And accordingly the judgment and decree was pronounced this term by a solemn presence, the lord keeper &c. being absent by infirmity.

And for the execution of double costs and damages recovered by the taxation of the Court, it was doubted what manner and form of process should be made: and after a conference thereupon had between all the judges of both benches, and the chief baron, it was resolved, that an English writ should be made, and directed to the sheriff of Nor. reciting the conviction, and the statute for the livery of the said costs and damages of the goods, chattels, and profits of the lands of Taverner, and to bring the money into the star-chamber, the writ to be sealed with the great seal, and the *teste or* witness, *the queen*, as is usual in similar writs in the chancery.

After this communication and judgment in the star-chamber, the queen pardoned the execution of the corporal punishment. Whether that be good without obtaining the release of the party also? *Quære* the intent of the statute of the fifth year of the now queen c. 14. Note, the preamble strongly penned to encrease the punishment of forgery. Also the body of the act s. that the party grieved shall recover double costs and damages, and that the offender shall suffer upon the pillory the corporal penance &c. And also shall forfeit to the queen the profits of his lands, but the plaintiff to be first satisfied &c.

Also, if the offender hath once suffered the corporal punishment, he shall not be eftsoons impeached &c. Also, if the offender be convicted, the plaintiff cannot release, or discontinue the punishment &c. but only costs and damages &c. And afterwards s. in the next Michaelmas Term it was holden by Wray chief justice, Saunders chief baron, Harper and Manwood justices, besides Bartham, and Gerrarde attorney, that the queen may pardon the corporal penance which trenches to the common example &c. But Dyer, Southcote, and Mounson, *è contra*.

[Trin. Jac. in the Bench Lord Coke said, that it was resolved by him and Popham, [13. Co. 64.] that if costs be assessed in the chancery, or star-chamber, the party upon refusal cannot be fined, or executors charged, but the person only is liable.

Trin. 41. Eliz. Popham said, that if a party hath recovered in forgery by false deeds, the king cannot pardon the corporal punishment, as he may where it is prosecuted in the star-chamber.

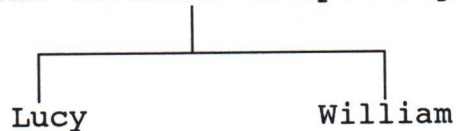

Since that time writer had searched all such records as he could find, for any wood-sale or any pavnage within the forest, but found nothing answered for. 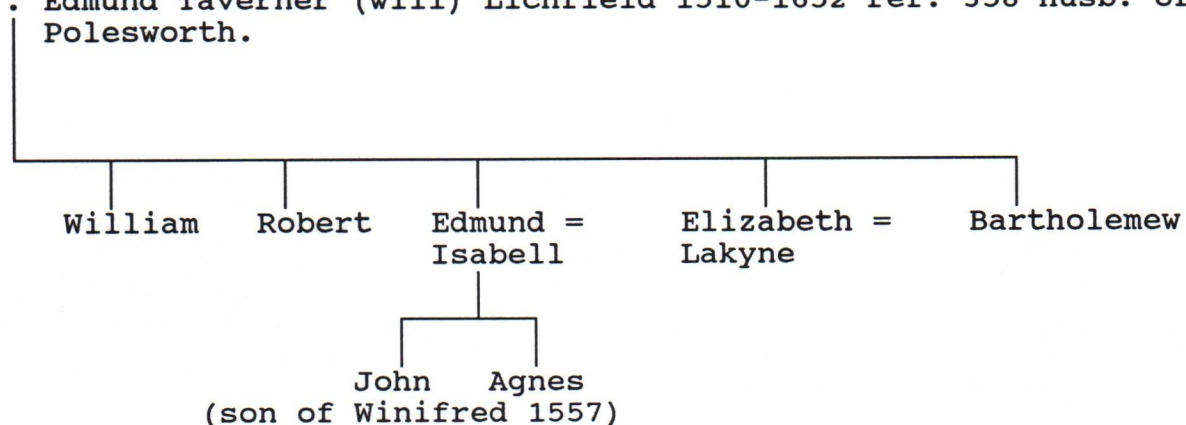

TAVERNER AND CROMWELL'S CASE.

Upon an evidence unto a jury, containing difficulty and matter in law; it was found, viz. that the Bishop of Norwich, 10 H. 8. [22 April 1518-21 April 1519] was seised of the mannor of Northeman in the right of his bishoprick; and, at his court holden within the same mannor, granted parcel of the demesnes of the said mannor to one Taverner and his heirs, where, of the said land in truth, there was not any demise by copy before: and so the said land continued in copy until 23 H. 8. [22 April 1531-21 April 1532] at which time, Taverner committed a forfeiture; which being presented, the bishop seised the land as forfeited; and granted the same again by copy to Taverner in fee: and so from thence it continued in copy until 8 Eliz. [17 November 1565-16 November 1566] (which interval between 23 H. 8. and 8 Eliz. amounted to 47 years:) [sic] It was the opinion of the whole Court in this case, that the continuance for 50 years, is requisite to fasten a customary condition upon the land against the lord. It was also agreed by the Court, that although the

original commencement, and that customary interest did commence 10 H. 8. ut supra, from which time, unto 8 Eliz. 60 years passed [*sic*]; yet the seisure for a forfeiture which happened 23 H. 8. interrupted utterly the continuance from the time which might by the law have perfected the customary interest. So that now, the time before the forfeiture ought not to be accounted in this case: but the original beginning of the copyhold shall be holden to be 23 H. 8. when the grant de novo by copy was made; between which time, and 8 Eliz. is an interval but of 47 years; within which time, a customary interest cannot attached upon the land: and then before sufficient time encurred, &c. the lord may well enter upon such a tenant at will: for as yet, there is not any custom begotten by sufficient time to bind him. It was also agreed by the justices, that if the lord of a manor is seised of an ancient copyhold for forfeiture, or by reason of escheat, and lett the same at will without any copy for divers years, one after the other, that that is not any interruption of the customary nature of the land; but that the lord may grant it again by copy.

As to other parcel of the land, it was given in evidence, that at a court lately holden at Northelman, it was presented by the homage there, that Taverner the plaintiff being a copyholder of the said manor, had forged a customary of the said manor, containing divers false customs, pretending them to be true customs of the said manor, and that he had forged, and put a seal to it, about which, this word, viz. (Northelman) is engraven; and that he had procured divers copyholders of the said manor to set their seals to it; and that he said unto them, that that customary should be put into the church of Northelman amongst the charters and evidences of the said church: and that he had now made his copyhold as good as his freehold. And, if the said offence committed by the plaintiff, ut supra, be a forfeiture of his copyhold, was the question? It was argued by Popham, who was of counsel with the plaintiff, that without further matter, it was not any forfeiture; and yet he confessed, it is a forgery against the first branch of that statute of 5 Eliz. cap. 14. And so he said it was lately adjudged in the Star-Chamber: but as to the point of forfeiture, he put this difference; if the lord demand his services of his copyholder, there, if the copyholder upon debate between the lord and himself, sheweth forth such a forged customary, and counterpleads the demand of the lord with it; now it is a forfeiture, for that the inheritance of the lord is thereby hazarded: as, if the copyholder after the forfeiture keep it himself, and doth not encounter the lord in his demand with it in his services, the same is not any forfeiture: as, if the

FONS

copyholder, before any rent be due, saith, that he will not pay any rent to the lord hereafter: or when a court is to be holden, that he will not after appear to do any suit at the court of his lord &c. But if, his rent being due, he denyeth it; or when the court is holden, he saith, that he will not do any suit; the same is a forfeiture: as it was lately adjudged in the Kings Bench, in the case between Sir Christopher Hatton, and his copyholders of his manor of Wellingborough. So if a copyholder being with the other copyholders charged upon oath to enquire of the articles of the court-baron, and sufficient matter being given to them in evidence, to induce them to find a matter within their charge, and they or any of them obstinately refuse to find the same, the same is a forfeiture of his copyhold: as it was adjudged in the case of Sir Rich. Southwell, Knight, and Thurston. Clench, Justice, conceived that in the principal case, the offence of the plaintiff, is not any forfeiture, no more, than if a copyholder makes a charter of feoffment of his customary land, and delivereth the same as his deed to the party, but doth not execute it by livery, the same is not any forfeiture. It was argued by Gawdy, Serjeant, who was of counsel with the defendant, to the contrary: for he said, that if a copyholder will forge a deed of feoffment, purporting, that the lord of the manor hath enfeoffed him of the said customary land, notwithstanding that he keepeth such charter himself, without shewing it forth, yet it is a forfeiture. At the length, the Court wishes the jury to find the special matter, and to refer the same to the Court, whether it was a forfeiture, or not. In this case, another matter was moved, viz. the aunccestor of the plaintiff had purchased divers several copyholds from several copyholders by several copies whereof he died seised; or committed several offences by which he forfeited to the lord all his copyholds, for which the lord seised, and granted them again to his aunccestor with the ancient rent, and to his heirs, *tenendum per antiqua servitia & consueta, &c.* And afterwards, the same copyholder commiteth waste, whether the same shall now trench to forfeit all the copyhold lands which were granted *ut supra*, by one entire copy; or only that which was before the seizure holden by the same rent, *et nihil ultra*: for these words, *tenendum per antiqua servitia*, do not trench only to the quantity of the services, but also to the quality; *scil.* severally, so as there shall be several services as before: as if A. be seised of copyhold land on the part of his father, and of other copyhold land on the part of his mother, and thereof dieth seised, and his son and heir be admitted to it by one copy, and by one admittance; now if that son dieth

without issue, the copyholds shall descend severally, the one to the heir on the part of his father, and the other to the heir on the part of his mother, &c. And afterwards, the jury found the special verdict, and the special matter, ut supra, &c.

If several copyholds are held by several tenures, waste in one of them is a forfeiture of that estate only, though they were all granted by the same copy. So if the copyholder surrender his several copyholds to one and his heirs, and the lord admit him *tenend' per antiqua servitia*; or if several copyholds escheat to the lord, and he re-grants them *tenend' per antiq' servit'* a forfeiture in one, is no forfeiture of the others.

In making admittances the lord is only an instrument, and the surrenderee, when admitted, is in by the surrenderor, and paramount the charges and incumbrances of the lord.

It was resolved [See the references *sup.*] by Wray, Chief Justice, Sir Thomas Gawdy, *et totam Curiam*, upon evidence to a jury, that if a copyholder be seised by force of several copies, *scil.* of Black Acre, by the rent of threepence and of White Acre by the rent of fourpence and of Green Acre by the rent of sixpence and afterwards the copyholder commits [1 Bulst. 51 [See *infra* n. (A).]] waste in part of Black Acre, or makes a feoffment of part of Black Acre, or denies the rent of that acre, by that all Black Acre is forfeited, [Cr. Wl. 353. [*Infra* n. (A).]] but it is no forfeiture of White Acre, nor of Green Acre [(A) S. C. and S. P. cited acc. Het. 36. Gilb. Ten. 217. 218. 246. 1 Watk. Cop. 334, 5. 1 Cru. Dig. 371. Vin. Abr. Copyhold Z. c. pl. 1. Bac. Abr. Copyhold L. 7. Com. Dig. Copyhold M. 3. But where the tenant holds several acres by the same tenure, it should seem that a forfeiture by any act committed in part will be a forfeiture of the whole tenement, for there is a condition in law annexed to the whole estate. Thus, if the copyholder commit waste in cutting down a single tree, this is a forfeiture of his whole tenement, Roll. Abr. 509.; and though it is said that if a copyholder makes a feoffment of one acre, parcel of his copyhold, nothing shall be forfeited but that acre, *id. ibid.* Gilb. Ten. 246, 7. 1 Cru. Dig. 371. Com. Dig. Copyhold M. 51.; yet as such feoffment, &c. is incompatible with the relation which the tenant bears to his lord, the better opinion appears to be that it will operate as a forfeiture, *infra* 27 b. 1 Watk. Cop. 335, 6. Bac. Abr. Copyhold L. 7. See further as to what estate shall be forfeited, *id. ibid.* 1 Cru. Dig. 371. Vin. Abr. Copyhold Y. c. Z. c. Com. Dig. Copyhold M. 3. 5. (ED.)]. For although they all are in one and the same hand, yet every acre is held severally, and to every acre there is a several condition in law [*Post* 28. [See n. (B). *infra.*] tacite annexed [(B) Acc. Gilb. Ten. 217. 1 Watk. Cop. 334. Vin. Abr. Cop. Z c. pl. 3. Bac. Abr. Copyhold L. 7. (ED.)], so as the forfeiture of the one cannot be the

forfeiture of any of the others: so it was at the same time resolved, that if the said copyholder of the said three acres severally held as aforesaid, surrenders them to the use of A. and his heirs, and the lord admits A. accordingly, (a) *tenendum per antiqua servitia inde prius debita et jure consueta*, or to such effect; and after A. commits a forfeiture in Black Acre, he shall forfeit that only, and none of the others, for the said *tenendum (reddendo singula singulis)* continued the several tenures [(C) Acc. The case upon demurrer was, divers copyholds were granted by one copy, and several *habendums* and several *reddendums* for every of them; but they all began at one time, and were to end at one time. The copyholder committed waste in one of the copyholds. The question was, whether that should be a forfeiture of them all? - Secondly, for this copyhold wherein the waste was done, which was cutting down trees, the copyholder prescribes, "that every copyholder of that parcel of wood hath used to cut down trees there growing." The question was, if such a prescription for one copyholder only was good? - Thirdly, whether the not coming to the Court upon summons at the church be cause of seizure?

For the first, all the justices resolved that they are several grants, and as several copies, and the forfeiture of the one is not the forfeiture of the other; and the several *habendums* and *reddendums* make them several in themselves, although they be all by one copy. *Vide* 4 Co. 27. a.

For the second, they held the prescription good. For Walmsley said, there is a difference between a prescription for freehold land and for customary land; for custom which concerneth freehold ought to be throughout the county, and cannot be in a particular place, 45 Assise. But a prescription concerning copyhold land is good in a particular; for *de minimis non curat lex*; and the law is not altered thereby; and it may be there is but one copyholder there, for which he might prescribe. - Beaumont agreed to this difference, and custom to have a profit *a prender*, privilege, or discharge, may very well be in a particular. And by Owen it was ruled accordingly in *Collis's case* in the Queen's Bench.

For the third, they conceived it to be no cause of forfeiture; for it shall not be a forfeiture but upon refusal to perform his services, or a wilful non-payment of the rent, or wilful absence from Court: but in this case it may be he had no notice of the summons, and knew not of the Court; for the summons properly is to be to his person, or at his house; or it ought to be averred, he had notice thereof.

And exception was taken to the summons, because it was but four days before the Court; whereas it ought to be fourteen days at the least. - And of that pinion was Walmsley. But the other justices were against him therein; for they

said the summons was well enough for the time. And it was adjudged for **Taverner** the copyholder.

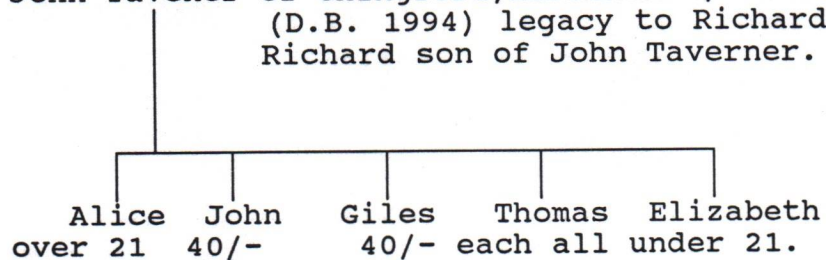

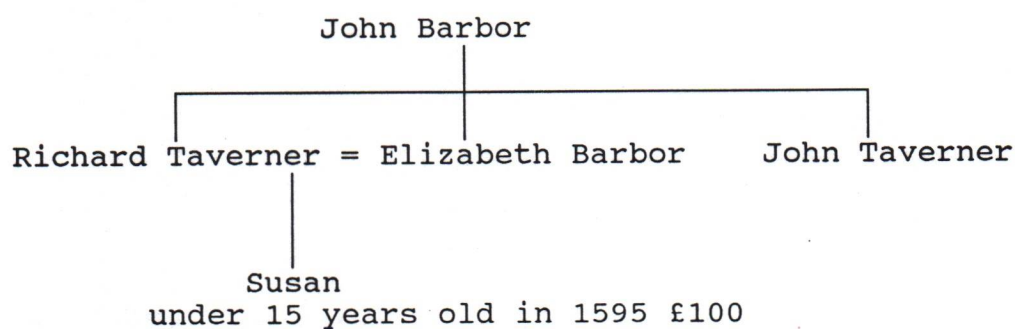

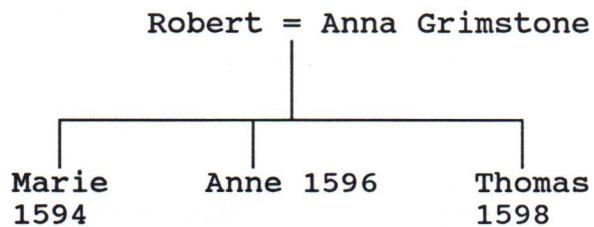
