3 August 1605 Dorset House

Letter: Earl of D[orset] to the Officers of the Works for the building of Ampthill House.

I have received signification of his Majesty's express pleasure for the building of a fit and convenient house upon the ruins of Ampthill in which he may be lodged, though not in state, yet sufficient to serve for the enjoying of his pleasures of hunting and hawking by the attendance of all such necessary officers and no more as are requisite for his royal person to have. Therein also place must be provided for the Queen and the noble Prince, if haply it shall please his Majesty to desire their coming while he is there, not lodgings of state but lodgings of necessity. And because it may be that some occasion may require the attendance of some of his Council upon his Majesty there, I wish also that some convenient rooms for half a dozen Privy Councillors besides the Lord Chamberlain, the Treasurer, the Controller, Master of the Horse and Principal Secretary be likewise appointed, such as are of necessity, not any of pleasure. Thus much as I conceive it touching the King's pleasure in general. But touching the particular; first, I require you the surveyor and controller with all speed possible to make your repair to the said house at Ampthill and there view and survey not only the stately place where the old ruins of Ampthill remain but also any other place (if any such be there) which may be found fitter and more convenient in respect of water or any other commodity for the seat of a house there for his Majesty in your opinion; but nevertheless to proceed in making of your present plot upon the ruins of the old house. And yet as I said if you find any other far better, only to be ready to inform his Majesty thereof and then his Highness to take his choice of that which shall be most to his pleasure; but to make the present plot upon your old and to make

an estimate of the charge of the said plot. Secondly, I require you the master carpenter that you presently take information of all the King's woods within thirty miles of the place from Mr. Taverner, his Majesty's general woodward on this side Trent; and thereupon that with all speed possible you repair to all the said woods and view the quantity and the several sorts of timber trees fit for this building at Ampthill, whereby when you shall see the particular plot made thereof, you may be the better able to declare whether his Majesty have sufficient timber in his own woods for the finishing of the same. And for more assurance I wish that you also inform yourself of all such other woods of any private person in which any special timber fit for the building may be had with the good consent of the owner. Thirdly, I require you the sergeant-plumber likewise to repair to the said house at Ampthill and taking view of the height to inform yourself of any fit place from whence water may be brought to serve the house within convenient distance and to make an estimate what will be the charge to bring the same in lead. These buildings being so greatly to the contentation of his Majesty, the preservation of his health and the continuation of his pleasures, of all which it is all our duties to take care more than of our own life, I charge you with all your pains and possible endeavours to further to your uttermost. And whensoever you shall need either my advice or help in anything, you shall find me so ready and willing as even with my own person I will come to the place, if need be.

Letter: R. Taverner to William Trumbull [?]

Sometimes having received courtesies above my present means to return proportionately I have so long deferred the performing what I might have lessened the debt with that I have not only passed the means I had to express my desire of thankfulness, but purchased to myself as ill conditions as the sin itself I most shunned could have laid upon me. This danger because I will not run the hazard of again I use to prefer a certain acknowledgment before a hoped requital. And this must be my apology to you. If for so liberal a letter as your love late bestowed upon me, I return you only my bare thanks till my store be increased I may do some act of thankfulness. Till yesterday we had not any passage from England hither this 10 days nor by this have I any letters. There is come one of the King's ships to carry over the young Duke of Brunswick who is not yet come, but expected from Paris every hour by his Governor, one Ostrot an Alman but an English knight, and Sir William Anstrowder and other of the King's servants but all Scots. He is expected against the tilting with great devotion, and is likely to receive a wonderful great entertainment. My last letters speak of the Parliament only this that it hath been much haunted with two words Contribution and Retribution. The Contribution 600,000£ present money to pay the King's debts and for the repairing of the Navy and the aid which the King hath promised the Marquis of Brandenburg, and 200,000£ increase of revenue for the maintenance of the King's children, the present being but sufficient for the King and Queen only. The Retribution was understood by the House to be the office of Wards and the trouble of purveyors for the provision of the Household. And by my Lord Treasurer it was so thrown amongst them that though they believed he

intended to quit the office and receive 5,000£ pension for it, and so were almost brought to these great conditions out of a hearty desire generally they felt to deliver their posterity of this burden, the greatest our gentry groaneth under, yet now they find him nothing inclined unto, nor can challenge any such offer of him though it was by himself so intimated that the whole House took it granted. But upon the assurance they were not to hope for it, the King's suit was utterly dashed, and what they have done since I hear not yet. But there is not one word spoken of the Union or of duels - the two chief things expected in this Parliament. For these parts I believe you receive too much of the air there to make you undervalue the French. We here think as meanly of the Spanish, and say the K. of France will set war afoot wheresoever he may find the Spaniard an enemy. The news of Cleve I am glad of, for I feared nothing but the pulling down that side so much too soon would be the spoiling of a towardly war. Spain's ratifying the marriage of Savoy with France I understand not how it can agree with what I heard that there is an offer made by the K. of Spain to Savoy of a daughter for the same son, and for dowry Millaine freed of all Spaniards and pensions and if the Prince of Spain die, the kingdom. The preparation of France is indeed very great, for the K. hath parted with his money already and it is distributed with the commissions for officers, for both places above 30,000 foot and 6,000 horse and 100 cannon, but they are all against the 15th of April which is when the K. hath put on a resolution to have all the Princes of the Blood and all the Peers of France swear allegiance to the Dolphin and disclaim all pretensions to the Crown which whosoever will make difficulty of he hath assurance to constrain or correct at his pleasure having so great an army under so assured leaders. And the Prince of Condy is so much beholding to men now to make this better reason than I ever yet heard he gave for himself of his coming out of France, that he foresaw the purpose and having no means to resist it ran from it. But I weary you with my ill intelligence. When we hear next from Paris, I promise amendment in my style. Yet take this more, that the League with France, England and the Low Countries is ratified, and there wanteth nothing but the Ambassadors of the States Mr. Bredrode and Melleree, to arrive at Paris for a full declaration. But the wind hath fought for you thus long, there having not one passage come out of the Low Countries from any part hither this month, and the Ambassadors having been ready almost so long. When this is done, look to yourselves. And of our Parliament this little

more. They have so false brothers among them that nothing is delivered that may be subject to a hard interpretation with the King which, if they be honest men must often fall out, but the King knoweth it presently, and it hath brought so base a fear amongst them, no man dareth speak freely. But they have it now in speech to deliver their voices by lot, as in Venice. I take my leave sorry I have not paper enough left to tell you how sorry I am for poor Kingsman and how much I hate Blunt and love you.

18 August 1610 Paris

Letter: Sir Thomas Edmondes to William Trumbull.

This letter was ready to go by Mr. Taverner who intended to go to Juliers by Brussels, but is now returned to Calais intending to go thence to Hoiland. We do not apprehend that the Archduke will send forces to the succour of Juliers fearing it should break his truce which he will be loath to hazard quelque mine qu'il face and now we think he hath not the power to do it though he had the will, for we hold the town as good as taken. Reconciliation is known to be made between the Emperor and his brother the King of Hungary, whereupon it is threatened that the forces which the Emperor entertained against his Brother in the Bishopric of Passau shall be employed against the Princes Associates, and the differences between Savoy and Spain being settled, forces will be sent from Lombardy to assist Archduke Leopold for the defence of the Bishopric of Strasburg, but this is ostentation, and it is hoped the taking of Juliers and the approach of winter will stop any new war this year. The Duke of Savoy hath sent his Secretary hither with his consent to the accommodating of his difference with Spain and to accept the offer of this State of 100,000 crowns' pension, and he will send his second son hither to be brought up. He is ready to conclude the marriage of his eldest son and Madame of France, for which purpose he will shortly send hither Monsieur Jacob. Though we live here in an exterior show of quietness, yet the discontentments between the great men and against the form of government remains very great. The Dukes of Bouillon and Sully intend to withdraw to their houses, ill satisfied, as well as many others, that they are excluded from participation in affairs, those which are of chiefest importance being solely governed by Villeroy. The Jesuits have obtained a sentence, to the great discontent of all well-affected

patriots, for their re-establishment in the same state as before their banishment which was more than they could ever obtain from the last King, howsoever he made show to favour them.

Mr Thomas Tauvner was buried of Lambourne 8th June - DBII 2.

At my return from you (at Bruges) I found Sir William Browne fallen into a relapse of his fever. He changed his world last night at 12 o'clock, having lyen speechless, striving with death from the same hour of the night before. His place no man thinketh of but the Sergeant Major. But I believe the company will be given to his son, and governed for him by a nephew he hath here, one Mr. Hough, which I wish because I know all his sickness he desired it more than ease or life, and sent his man twice into England about it. His Excellency hath been at Middleborough almost a week, and is so wearied of their chaos of business and insatiable emulation of those of Holland that he intendeth to leave them the end of this week. My Lord of Cranborne had his wish into England and I desire he may have it there. He went down presently with my Lo. of Walden to assist him in the funerals of Viscount Byndon.

Letter: Mr. Taverner to William Trumbull

You know the Baronets go forward, and that there are now some 50 have given their names to perform the king's conditions of 2,000£ for the business of Ireland, and they say there will 20 baroneys after be had for 5,000£ a baron, There have happened since my being here two irreconcilable quarrels and undeterminable. The first between our General Cecill and Captain Horwood, who have exchanged as much bitterness as rage and malice can think. The lie remaineth on Horwood who hath dared the general to the sword. And he taketh the advantage of having been a general to despise him and saith he will set a captain to him. But the prince, whose servant Horwood is in the Privy Chamber, and the opinion of the time are on Horwood's side. The prince studieth to compound it, but the wrong is so great words cannot satisfy it; so it must rest till it be adjudged whether a general and a captain may fight. The other and greater hath been between the queen and my ld. of Rochester. On Monday last [27 May 1611] Rochester and his dear Overbury, walking in the garden at Greenwich whither the queen's window openeth, she broke into a sudden and contemptible laughing at them. "So," saith she, "they did at her," which belief carried her so far that she went to the king with tears in her eyes and complained and besought him not to suffer her to be so scorned and despised of his grooms, though she were content to suffer it from him, with earnest protestation that if he would not right her, she would go back into Denmark. All this while the good king much afflicted walked up and down the chamber. "Ah, woe is me, my queen will go from me, my Carr, my Carr." But doing nothing to content her. The next day she sent to the prince to Richmond to entreat him, and so to the lords in Whitehall to come to Greenwich to have the hearing of her cause, where on Wednesday it was

cunningly urged by her and as confidently denied by them. The conclusion was, she finding herself not able to supplant Carr, which she desireth of all things in the world, turned all her force against Overbury, against whom she hath so far prevailed that he is banished from the Court. Taverner and his assignes to pay £10 rent at certain feasts annually, and then the lessor grants the reversion for life to Mary and then attornment to the same, Mary makes lease of her reversion for 40 years should she so long live, to which S. attorns, and then his term is devised to his wife, and he dies, and she Marie with the defendant and the plaintiff as Mary's assignee, assignee of T. Taverner brings this action for non-payment of the rent at one feast, and avers that at the time of the feast and for a long time then Mary was in full life. Upon this was demur. H. Davies, It seems that the covenant of the lessee in the indenture to pay a rent could not make this be a rent, but that it is as if a sum in gross, because there must be apt words for a reservation such as 'to pay, to hold &c'. 30 Ass. pl. 3. 'Saving' does not create a rent, also in the reservation there must be lease words to reserve, Obj. a covenant by indenture is both words, the covenant is general and not and not said by what is done there will be the words of both, and more especially of that which must name them, but where the person is named who speaks them it cannot be taken that any other speaks them, 26 H. 8. 2. in an indenture a covenant was made by the feoffee of husband and wife to pay annually so much rent, after the death of the husband the wife accepts the rent, yet this did not affirm the feofment because it was as if a sum in gross, but it would have been otherwise if this had been a rent, D. 10 El. 275, 49. Lessee covenants by the indenture of lease to pay so much rent annually athe usual feasts and resolves that the Queen should not have the rent, she having the heir in ward, because this was not a reserve rent but a sum in gross, our case in the Com. Brow. Beston. is a doubt. Guinne against, the indenture is that in consideration for the payment of the rent 'hereafter mention' the lessor leases &c. and then the lease makes the covenant, as above, and sp this makes the case without question that this will be a reservation of the lessor, but if it had been, as if a mere convenant by the lessee as Brown and Bestons case is, still it seems that this would have to be a rent which was granted by Coke, who says that when he first came across the said case of the Com. he marvelled much that this should have caused any doubt, for I have always held this to be a clear case that it is a rent, for a covenant is to covenant this is an agreement which must be by both parties, and therefore this word (covenant) is the word of bothg parties, whereas a contract is an act against an act, and in our case this covenant would be a

reservation of a rent more especially because it is as it were a chattel; the other justices say nothing as to this, but with their consent the plaintiff had judgment such that it was adjudged to be a good rent as this case is, for Coke & Dod. say (and the others seem also to agree to this) that this case is clear because of the words aforesaid ('in consideration of the payment of the rent hereafter mention') which is good rent.

Tuesday, 10 Feb. [1628/9]

Report was made of the Committee's opinion concerning the privilege of peers to be freed from attachments out of the Chancery and Star Chamber. They found a case clear in the point 14 E. beyween the Lord Cromwell and one Taverner, and that then the Lords freed the Lord Cromwell and set down an order with a proviso. See the record. Accordingly the Lords set it down then that precedent should be followed, with the same proviso.

Then there grew a great debate what remedy should be against a peer if he were not liable to attachment. The Lords, for the Justice of the Realm, thought fit there should be some course taken, and so the consideration of that was committed to the committees of privileges.

Then it was moved to enter into debate for that which yesterday was ordered concerning foreign nobility. The House chose the former committee to sit to consider of the course and to go in hand presently, whereupon the House was adjourned till Thursday, 9; and committees went into consideration, and after much debate put off till to-morrow in the afternoon, and then everyone that would to set down his conception in writing.

Debt upon an obligation of one hundred pounds, conditioned to perform the award of J. S. and J. D. so as they make their award before the tenth of October following, under their hands and seals; and if they did not agree, then

to stand to the umpirage of J. N. so as he made it in writing under his hand and seal before the twentieth of October following.

The defendant pleaded, that the said J. S. and J. D. did not make any award before the tenth of October, nor J. N. the umpire before the twentieth of October, &c.

The plaintiff replies, true it is that J. S. and J. D. did not agree, nor make any arbitrament before the tenth of October; but that J. N. the umpire did make an award before the twentieth of October under his hand and seal, and shews it; wherefore *inter alia* the defendant was to pay to the plaintiff thirty pounds upon such a day, at the house of William Sutton, in Chelmsford, being the sign of the Cock; and for the non-payment of the said thirty pounds alledgeth the breach.

The defendant thereupon demurs.

Wright, for the defendant, moved, that this submission is void and uncertain; for it is, "if they do not agree," and it doth not appear to what they should agree; and an uncertain submission is void.

Sed non allocatur: for the words, "if they do not agree," have the intendment, if they do not agree and make their arbitrament under their hands and seals before such a day; for otherwise it is quasi no agreement within that condition. Wright then moved, that this arbitrament by the umpire was void; for he appoints money to be paid at the house of a stranger, wherein by intendment the defendant hath no interest, nor can compel him that is owner of the house to suffer money to be paid there: and an arbitrament ought not to appoint a thing to be done to a stranger, or by a stranger, over whom the defendant hath not power, nor in a stranger's house; by which act the defendant might be a trespasser. 5 Co. 77. 22 Hen. 6. pl. 46.

But all the Court agreed, that the arbitrament was good; for the appointment of the payment of the money at a stranger's house (especially being by intendment a common inn) cannot be unreasonable, or shall make an unlawful act; but by intendment the plaintiff will procure such kindness that the money may be paid there: and if the stranger shall deny the payment to be there, it peradventure may be a good excuse for the defendant: but the arbitrament by itself, *primá facie*, is good enough.

Whereupon it was adjudged for the plaintiff.

This day the Lord Privie Seale, Mr. Treasorer and Mr. Secretarie Coke made Report unto the Boord how that according to the order of the 14th of January, they, beeing assisted with the persons in that order mentioned, had calloed before them all parties concerned in that cause, and, finding all things informed in that order to be true, they much blamed both the Governors and Government of that Levant Company in that they had not taken some faire course amongst themselves for satisfaccion of a debt of this nature taken upp of the Citty out of Orphants money for the common use of the Levant Companie, though private men stood bound and engaged for the money. Wherefore all things considered they thought fitt that the Company should speedely assemble and take such a course amongst themselves that the debt demanded might be speedely satisfied. And if no better way should be thought of, that then according to a Schedule exhibited, signed by the Clarke of the Councell now attending, wherein the names and sommes of the severall debbitors are set downe and expressed, levyes should be made upon the goods of the said debbitors, which they or any of them have either heere in England, or in parts beyond the Seas where the said persons of the Company do trade. And if any of them shall refuse to pay their ratable parts according as in the said Schedule is sett downe, then good Bonds to be taken by the said Maior of London for the apparance of the said persons before this Boord, where they shall find a strict course to be taken with them, not onely to compell them to satisfie their portions in the schedule set downe but to be further dealt with as persons refractary to order and Government, which if it should goe unpunished would aswell induce dishonor to the State as discredit and disorder in all Companyes. This Report beeing redd the Lords all approved thereof and commanded that before the end of the next moneth of June course should be taken accordingly.

That there have lately bene two severall trialls att the Kinges Benche barre for the Churchgate house in question, and the landes thereunto belonginge, betwene the defendant Edward Leigh and the said Complainant, att the later of which trialls this deponent was present ["and a witnes" deleted] and sayeth that the verdict did passe att the said later triall for the said Mr Leigh, and also att the former triall, as this deponent hath heard.

And further deposeth not to any the questions of this Interr.

And further deposeth not to any the questions of this Interr.

8. That the said Robert Scot is a very poore creature, And soe conceyved amongst the Inhabitantes of Chickford, and is weekely allowed, and doth take his Almes of bread among the rest of the poore of the same parishe,

And more sayeth not to any the questions of this Interr.

9. That the said Robert Scott was produced as a witness at the later of the said two trialls on the said Complainant Mr Bothbyes part,

And sayeth that the said Robert Scott was then demaunded by the Court whether he did know of any Lease made of the landes in question, whereunto the said Robert Scott Aunsweared att the first, that there was a lease parall made of it, and afterwardes that there was a lease made of it in writinge, and that his, the said Robert Scottes, hand, was to it, or to that effecte, but the Court beinge informed what manner of person he now was, his testimony was nothinge credited, but the verdict passed for Mr Leigh againste the said Mr Bothby, for whom the said Robert Scott was produced, and contrary to the said Scottes testimony,

And sayeth that the said Scott himselfe hath, in a boastful manner, cast out many Idle speeches to some such effecte, and believeth that the saud Scott was himselfe the author of the said Report, but this deponent doth not remember that he did ever see the said Robert Scott produce or shewe any store of money as by the Article is questioned, nor can further materially aunsweare for satisfaction of any the questions of this Interr.

- 12. That all that he can materially depose for the satisfaction of any the questions of this Interr. more then what he hath already deposed in Aunsweare to the next precedent Interr. is that the said Robert Scott had the said coate before spoken of, and which was said to be bought for and given him by the said Mr Boothby or by his appointment, on his backe when he gave in evidence att the said last triall.
- 13. That some three weekes or thereaboutes before the said last triall at the Kinges bench barre for the said landes in question John Russell, Clerke, Parson of Chinckford aforesaid, did come to this deponent, to this deponent's house in Chinckford, and did there take this deponent aside, and told this deponent that this deponent might doe the said Complainant Mr Boothbye a great curtesy, worth a hundred poundes and above, and that this deponent might thereby also doe himself, his wiefe and children much good,

And this deponent demaundinge wherein, the said Parson Russell said, in makinge but oath att the triall that there was a lease of the said Churche gate house and landes ["had been leased out" deleted] whereunto this deponent made Aunsweare to the said Mr Russell that he was partner in the said groundes with the said Field when he held them, and did knowe that the said John Field held them only att the will of the Lord, and had noe lease of them att all, and therefore could not nor would not take such an oath if he ["might" deleted] were sure to gayne Five hundred pounds, or to that effects.

And then the said Mr Russell did tell this deponent that he might take that oath and yett never hurt his sowle, and further offered this deponent that if he would sweare it, this deponent should have halfe a peece, and he would give this deponentes wieffe two peeces more, and that this deponent should rent what landes he would of the said Complainant Mr Boothby, and did then put a tenne shillinge peece of gold into this deponent's hand. But this deponent delivered him his said gold againe and aunsweared him that he would not take such a false oath if he would give him a hundred poundes,

And then the said Parson Russell did bid this deponent consider of it and sleepe upon it, and he would come to this deponent againe on the morrow in the afternoone, and accordingly did come againe to this deponent on the morrowe in the afternoone and did much presse this deponent, and this deponent refusinge, the said Parson Russell would not depart but did come againe, in all fower severall tymes, both to this deponent and his wiefe, to have corrupted this deponent to have taken that false oath.

And this he sayeth is the effecte of what he can materially depose for satisfaction of any the questions of this Interr.
