

FUN WITH FEET OF FINES

Most old property transactions were recorded three times, one for the purchaser (plaintive) one for the vendor (defendant) and the third copy was kept as a record of the transaction in the Court of Common pleas. The three copies were all written on one piece of parchment which was torn into 3 pieces.



A, B & C the court kept portion C or the foot of the page hence the name feet of fines.

In Essex, each fine or transaction has been summarised from the earliest records until 1603 and published into volumes. I have volume 5 & 6 which cover the period from 1547 to 1603.

Attached are the summaries of land sale and purchases in Essex by the Taverners over this period extracted from the feet of fines. A researcher has also gone back through the other volumes, and these are also attached. Lastly and to complete the picture I attach those other records I have.

WEST THURROCK

In volume I of the Taverners I quoted from a history of Essex hundreds: - Sir William Hollis had 22 acres called Ordwyns and 27 acres called Quernys. Sir Thomas Hollis, his son and heir joining with others in a fine in 1547 passed it to Robert Taverner, and within 4 years it was in the hands of Robert Long, citizen and mercer of London.

The entry in 1547 states: - "Easter and Trinity" Henry Hardson and Thomas Oules, citizens and skinners of London pl. Thomas Holles, knight, and wife Anne, Richard Taverner Esq, Roger Taverner and Robert Taverner def, Manor of Westhurroke alias Westhall in Westhurroke alias Le Vynyard and 26 tofts, 20 gardens 1 dovecote, 1 windmill, 600 acre ar, 100 acre mw, 370 acre pa, 100 acre wd, 100 acre marsh, 200 acre furze and heath, and £10 rent in Westhurroke, Duddinghurst, Harmyrys, Orsed, Styfford, Grace, (Lt Baddow), Aulflye & Gorys, (Hammond-on-the-Hill), def quit claimed to pl, and the heirs of Henry with separate warranties for the heirs of Ann and Richard = £1,960.00.

Clearly the two references are to two different parcels of land. So far I have not found out how Richard, Robert & Roger acquired a share of the estate, but assuming they each got equal shares, it does explain where a large part of their wealth came from.

"The place names of Essex" says that 'Thurrock' describes the hold of a ship wherein is gathered all the fylthe that cometh into the shippe.

A passage in Comden describes the type of landscape. In the marshy ground adjoining the Thames about West Thurrock, Dagenham etc great numbers of subterraneous trees have been discovered by the inundations of the Thames.

"High Ho Olim West Hall is Westhurroke alias Westhall (alias Le Vynyard) 1517, 1547 F.F. In the West of the Parish. Now named in distinction from Low Ho. This must be the lands quondam vinet 1423 St John".

I can identify most of the characters as follows:-

Richard, Robert & Roger Taverner were brothers whom we met in Volume I of The Taverners page 14 as 3 of the 4 sons of John Taverner of North Elmham in Norfolk.

John Taverner & wife Margaret - I have not yet identified. Rumbold Taverner is part of the 'Hatfield' Taverners. Ralph Taverner and Joan are also descendants of the 'Hatfield' Taverners. Thomas Taverner and wife Ann, Robert's son (see Volume I Page 26). John Taverner and wife Joan - not yet identified. Robert Taverner - not yet identified.

Although Thomas and Ann sold a proportion of their properties in 1591 and 1598 he lived at Lambourn until his death in 1610. Their eldest son Robert born 1588 eventually sold the property called Arneways in 1625 to Robert Draper.

ROBERT BORN 1588

1625 18th November Robert Taverner gent and Ann Godman to Robert Draper citizen and merchant tailor of London of a messuage called Arneways.

Bond in £4,000.00 28th November 1627. Robert Taverner of Lambourne, gent and Thomas Taverner (his younger brother) merchant tailor of London, to Robert Draper merchant tailor of London.

List of Jurors Ass 35/63/H/56 11th March 1622 Robert Taverner of Lambourne and Frances Taverner of Halstead.

1622 Q/SR 237.21 - Presentment against the inhabitants of Lambourne for not repairing a horse bridge in the highway between Abridge and Mr Taverner's.

Of Thomas & Ann's son and daughters Richard is easiest to trace. Born at Lambourne in 1597 he became a london merchant the parish of St Andrews-by-the-Wardrobe. He married probably in 1631 at St Margaret's Westminster to Margaret Harris. He had 2 sons Richard baptised in 1635 and John in 1639.

John in 1671 became a notary public in the Court of Arches of Canterbury, and left London for Jamaica! In his application for notary, he described himself as a citizen of London and as having served an apprentiship as a scriviner.

Thomas and Ann's son Thomas of London in the visitation of 1634

He went to Cambridge - Matric sisar from Kings College at Michaielmas in 1602, he is described as a merchant tailor in 1637 in the visitations.
